In our continuous efforts to promote safety for our students, the Bow Police Department has been actively working with the Bow Schools and the bus company to ensure a presence around school buses before and after school. This initiative aims to deter the dangerous practice of motorists passing stopped school buses, protecting our children as they travel to and from school.

As we navigate the roads of Bow, I want to remind everyone to drive safely. To further strengthen our traffic enforcement efforts, we will continue to utilize traffic enforcement grants from the New Hampshire Office of Highway Safety, focusing on keeping our roadways safe for all users.

On April 7th, Officer Seth Guilmette and K9 Hunter will begin an 8-week Narcotics detection training program. K9 Hunter has already demonstrated impressive tracking abilities, particularly in a recent missing person case. We are confident that his acute sense of smell will excel in drug detection, and we look forward to seeing what they can accomplish once the training has been completed.

## School Bus and Student Safety

In coordination with Bow Transportation, Officers will be proactively patrolling bus routes for school bus violations. There has been a recent increase in complaints from Bow Transportation that drivers are not stopping at flashing red lights and school bus stop signs.

BPD treats bus and student safety as a priority and will be following school buses during their routes for violations.

### **NH 265:54 - Overtaking and Passing School Bus**

I. The driver of a vehicle upon a way upon meeting or overtaking from either direction any school bus, plainly marked with school bus signs or such other distinguishing identification as the director may require, which has stopped on the highway for the purpose of receiving or discharging school children shall stop his or her vehicle before reaching such school bus at least 25 feet away from such school bus. The driver shall not proceed until such school bus resumes motion, or until flashing red lights cease to operate.



### **Passing a school bus:\***

First offense: \$186

Subsequent offense(s): \$310

### **Passing a school bus on the right:\***

\$610

\*Can also include suspension of driving privileges

## SHERRILL'S LAW (NH RSA 265:37-a) (MOVE OVER LAW)

CONCORD, N.H. – Members of the New Hampshire Senate unanimously passed legislation expanding and renaming New Hampshire's 'Move Over' law in honor of State Police Staff Sgt. Jesse E. Sherrill. On Oct. 28, 2021, Staff Sgt. Sherrill died in the line of duty while working a construction detail on Interstate 95 in Portsmouth when his cruiser was struck by a tractor-trailer. Investigators later determined the driver of the tractor-trailer failed to move over to the next lane, despite passing at least two advance warning signs and observing multiple warning/emergency lights, according to the indictment filed in the case. The driver later pleaded guilty to felony charges of negligent homicide and reckless conduct.



### **265:37-a Motorist Duties When Approaching Highway Emergencies "SHERRILL'S LAW"**

I. When in or approaching an incident involving a fire, collision, disaster, utility construction or maintenance, or other emergency resulting in partial or complete blockage of a highway, or a location where a police officer has made a traffic stop, every driver other than the driver of an emergency response vehicle, shall:

- (a) Maintain a reduced speed.
- (b) Obey the directions of any authorized person directing traffic and of all applicable emergency signals and traffic control devices.
- (c) Vacate as soon as possible any lane wholly or partially blocked.
- (d) Give a wide berth, without endangering oncoming traffic, to public safety personnel, any persons in the roadway, and vehicles displaying blue, red, or amber emergency or warning lights.

II. Any person violating this section shall be fined \$75 plus penalty assessment for a first offense and \$250 plus penalty assessment for a subsequent offense in a 12-month period.
