

## K-9 Hunter Drug Arrest



On Sunday, June 22, 2025, the Bow Police Department arrested Joshua Davis, 44 years old of Concord, for operating while a Habitual Offender. After an on-scene investigation by Officer Guilmette and his K9 Hunter. A search warrant was obtained for Davis' vehicle, after K9 Hunter alerted to drugs in the vehicle. As a result of the search, a large quantity of illegal drugs, a stolen firearm, and a large amount of US currency were seized.

Davis was charged with four counts of possession of a controlled drug with intent to sell and four counts of possession of a controlled drug, possession of Stolen Property-Firearm, Transporting Drugs in a Motor Vehicle, two counts of felon in possession of a dangerous weapon, and Armed Career Criminal. Davis refused bail and will be arraigned in Concord District Court from the Merrimack County House of Corrections.

## Arrest - Possession of Child Sexual Abuse Videos

Elder Antonio Lopez-Fletes, 31, a Honduran national temporarily residing in Bow, was taken into custody following a search and arrest warrant operation conducted by the Bow Police Department in conjunction with the New Hampshire Internet Crimes Against Children Task Force (NH ICAC).

The arrest of Lopez-Fletes follows an approximately six-month investigation led by Detective Sergeant Coady. Lopez-Fletes faces five felony counts of possession of child sexual abuse material. The operation involved a significant collaborative effort between various law enforcement agencies. We thank NH ICAC for their assistance in today's operation as well as their committed effort to investigating internet crimes against children.

NH RSA 597:2 prohibits the release of any person who is charged with RSA 649-A (Possession of Child Sex Abuse Images) pending arraignment. Lopez-Fletes was transported to the Merrimack County House of Corrections and was arraigned on Friday, June 20th, 2025, in the 6th Circuit – District Division – Concord Court.

## Suspicious Person Call Leads to Arrest

On Thursday, June 12, 2025, at approximately 2:30 pm, officers responded to the intersection of Page Road and Branch Londonderry Turnpike West following a report of a male acting suspiciously at a school bus stop.

Upon the officers arrival, a pickup truck pulled in directly behind the marked police cruiser. The same male subject who had been reported as acting suspicious, exited the vehicle and approached the officers. Officers immediately detected a strong odor of an alcoholic beverage emanating from the individual and observed signs of visible intoxication. The male was uncooperative with officers on scene. When informed that he was being placed under arrest, he became combative and resisted attempts to be handcuffed. After a brief struggle, officers successfully secured him in handcuffs and took him into custody.



The male was identified as JAMES MICHEL, 39, of Bow, and has been charged with Driving While Intoxicated, Resisting Arrest, and Simple Assault on a Police Officer. Both MICHEL and a Bow Police Officer were treated for minor injuries at Concord Hospital. MICHEL requested bail, which was set at preventive detention. MICHEL is currently being held at the Merrimack County House of Corrections until his video arraignment on Friday, June 13, 2025, at 11:00am at the 6th Circuit – District Division – Concord Court. The Bow Police Department was assisted on scene by the Bow Fire Department.

### Law of the Month

NH RSA 265:79-c

#### Use of Mobile Electronic Device While Driving

I. (a) No person, while driving a moving motor vehicle upon a way or temporarily halted in traffic for a traffic control device or other momentary delay, shall use any hand-held mobile electronic device capable of providing voice or data communication, including but not limited to: reading, composing, viewing, or posting any electronic message; or initiating, receiving, or conducting a conversation; or initiating a command or request to access the Internet; or inputting information into a global positioning system or navigation device; or manually typing data into any other portable electronic device. An operator of a motor vehicle who holds a cellular telephone or other electronic device capable of voice communication in the immediate proximity of his or her ear while such vehicle is in motion is presumed to be engaging in a call within the meaning of this section.

##### When is it OK to use an electronic device while driving?

- ✓ Calling 9-1-1, police, fire, or EMS to report an emergency
- ✓ Using one hand to use a non-cellular 2-way radio
- ✓ Using a Bluetooth or hands-free electronic device (integrated into a motor vehicle)
- ✓ Perform an action required by an interlock device
- ✓ Phone mounted for GPS navigation
