The holidays also bring gatherings and celebrations. If your plans include alcohol, please make responsible choices, designate a sober driver, use a ride-share service, or call a friend. Impaired driving endangers everyone on our roads. Throughout December, the Bow Police Department will increase DUI and speed enforcement patrols using grant funding provided by the New Hampshire Office of Highway Safety. With the increase in online shopping and package deliveries, please remain vigilant against porch pirates and holiday-related scams. We have already seen reports of fraudulent calls claiming to be from well-known delivery companies and emails requesting payment or personal information to "release" a package. Legitimate carriers will never ask for payment or sensitive data via unsolicited calls or emails. If you are expecting deliveries, consider using tracking notifications, requiring a signature, or arranging for packages to be held at the retailer or shipping facility.

As always, your awareness and cooperation are essential to keeping Bow a safe place to live, work, and visit. On behalf of every member of the Bow Police Department, I wish you and your families a safe, healthy, and happy holiday season.

## LAW UPDATE 1/1/2026

**466:31-a**

### Penalties for Nuisance Dogs



The fines for nuisance dog offenses will be updated effective 1/1/2026. HB670 was signed into law on 7/15/25. The new fines are listed below:

- (a) A warning for the first nuisance offense under RSA 466:31, II(a), (b), (c) or (d); \$50 for the second offense committed within 12 months of the first nuisance offense, \$100 for the third or subsequent nuisance offense committed within 12 months of the first nuisance offense.
- (b) \$200 for the first menace offense under RSA 466:31, II(e) or (f); \$400 for the second or subsequent menace offense committed within 12 months of the first menace offense.
- (c) \$400 for the first vicious offense under RSA 466:31, II(g). Additionally, the owner of the dog shall be liable for all medical bills sustained by the person who was attacked.
- (d) \$1,000 for the second or subsequent vicious offense committed within 12 months of the first vicious offense under RSA 466:31, II(g). Additionally, the owner of the dog shall be liable for all medical bills sustained by the person who was attacked.

## Jessica's Law



### 265:79-b Negligent Driving (Jessica's Law) –

Whoever upon any way drives a vehicle negligently or causes a vehicle to be driven negligently, as defined in RSA 626:2, II(d), or in a manner that endangers or is likely to endanger any person or property shall be guilty of a violation and shall be fined not less than \$250 nor more than \$500 for a first offense and not less than \$500 nor more than \$1,000 for a second or subsequent offense.

Please take the extra time to make sure your vehicle is properly cleaned of snow and ice before you hit the road. Not only does it keep other motorists safe, it is the law!

Officers are out after each snow storm enforcing Jessica's Law. Fines are steep for a reason. Flying chunks of ice and packed snow can cause death, serious bodily injury, or significant property damage.

## Public Safety Alert

The Bow Police Department is issuing an alert regarding two recent vehicle break-ins and thefts that occurred 11/09/25, between 12:00 PM and 1:00 PM at local trailheads on South Bow Road and Robinson Road.

In both incidents, vehicle windows were smashed, and purses and other expensive items were stolen from inside the vehicles. These crimes are often carried out by suspects who watch the trailheads, waiting for vehicles to be left unattended.

We urge all residents and visitors to never leave valuable items in plain sight in your vehicle while hiking, or anytime for that matter.

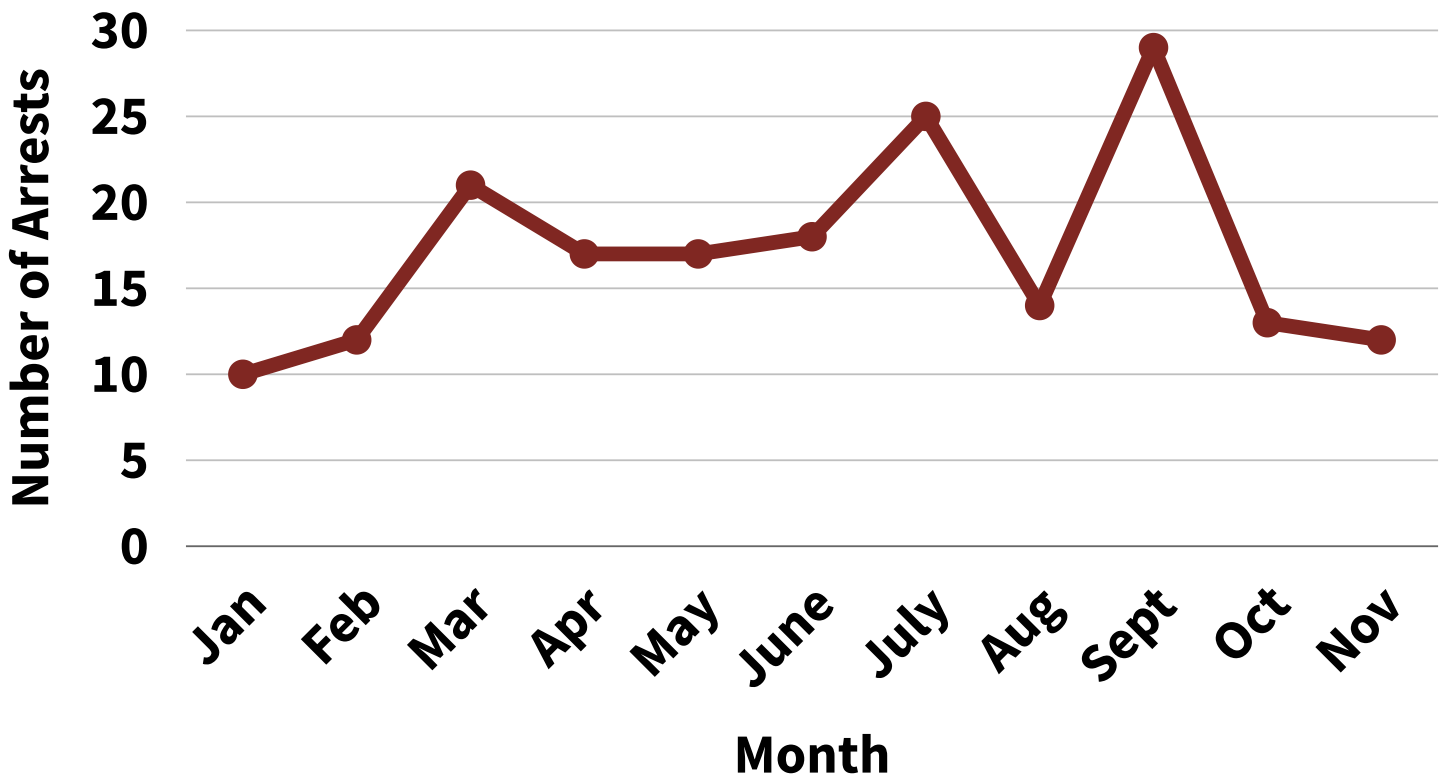

The candidates who receive their final offer of employment are expected to attend the May 2026 NH Police Academy.

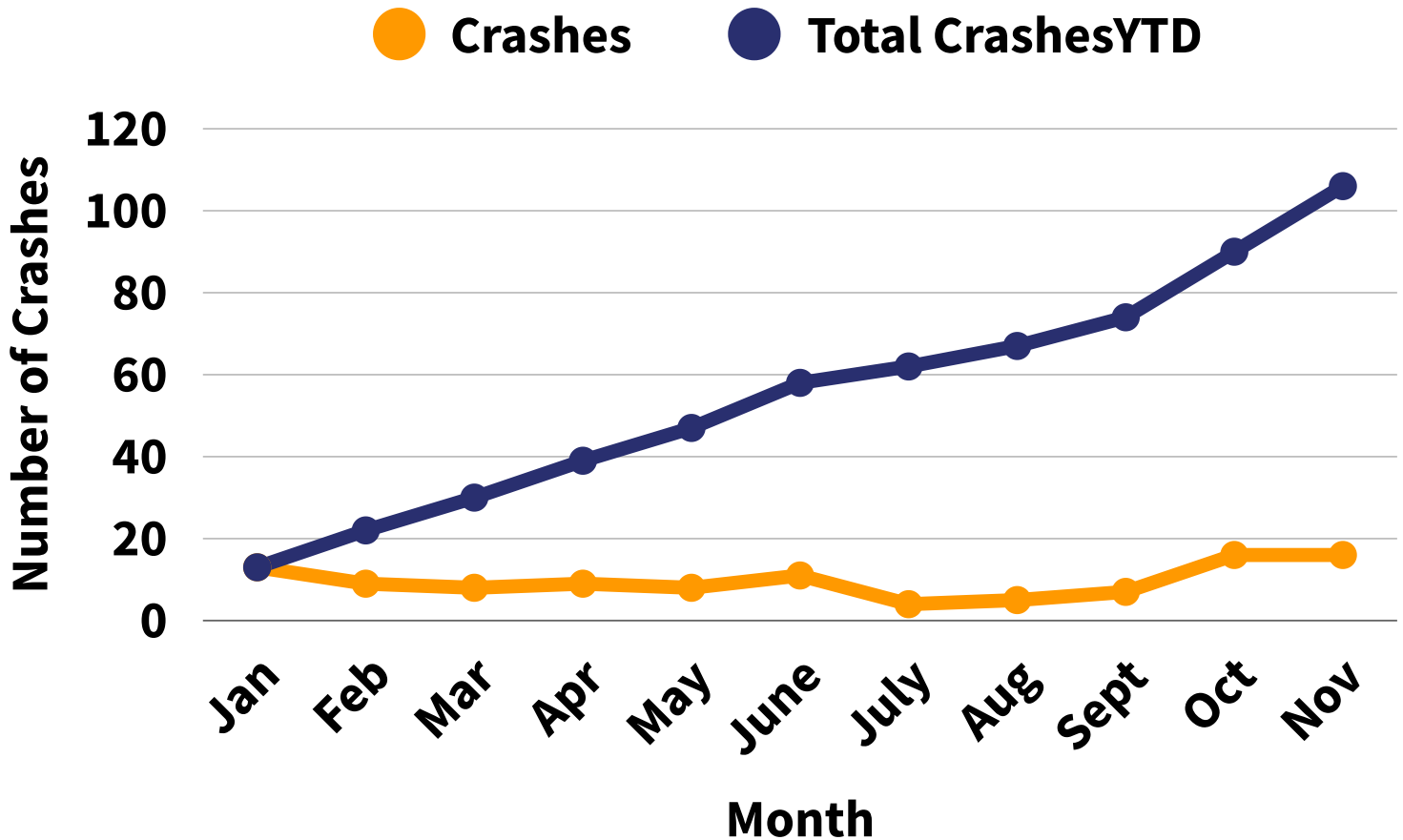
