## Town Manager's Report

### Budget Process

The Board of Selectmen has completed its review of the proposed FY2018-19 Town budget. The Board's budget will now be submitted to the Budget Committee for its review beginning in January to February. The Committee will be reviewing both the Town and School District budgets. The Committee has not finalized the schedule. Meetings will be posted on the Town website.

### Property Tax rate and Eversource

As you all are now aware, the Town's property tax rate has increased 5.6% over the 2016 rate. When the Town and School budgets were approved at last March's Town and School Meetings, the projected 2017 tax rate was \$26.27, which would have represented a two cent drop from the 2016 tax rate. The 2017 tax rate is \$27.77. So, what happened?

There are two reasons why the rate is higher than anticipated and both are related to a drop in the assessed value of the Merrimack Station power plant. Approximately one-quarter of the increase can be attributed to a decision made by the Board of Selectmen to lower the assessment of the plant to equal the \$75 million sale price that was recently approved by the Public Utilities Commission. This equates to a \$20.5 million drop in value. The remainder of the increase was caused by a \$1.2 million increase in the amount of funds raised for potential property tax abatements. Both of these actions were taken by the Board of Selectmen to help to alleviate the total financial impact of the plant's value change.

In spring, 2016, the Superior Court heard an appeal from Eversource contesting the Town's 2012 and 2013 assessed values for all of the company's properties located in Bow. The Court issued its ruling in October, 2016 and it was in favor of Eversource. The Town filed an appeal of that decision with the State Supreme Court, and the appeal was heard on October 12, 2017. Any amount to be refunded will not be certain until the court case is concluded. The 2014 through 2017 tax years are not covered by the case. That being said, the Town's liability for the 2012 and 2013 tax years could exceed \$14 million.

### Lighting and engraved bricks at Safety Center

The sidewalk lights were installed on Monday, 11/20. Since it is late in the season, DPW is recommending that the installation of bricks is best done next spring. The trench that was dug to run electricity to each light was re-filled and needs to settle.

### **Board of Selectmen Appointments**

Madhumita Chatterjee was recently appointed by the Board of Selectmen to serve a three year term on the Drinking Water Protection Committee. Established by the Board in 2006, the Committee's role is to ensure clean water for all Bow residents and employees. Welcome, Madhumita.

### **Stay Safe this Winter Holiday Season**

Each year, thousands of deaths are caused by fires, burns and other fire-related injuries. The National Fire Protection Association reports that the increased use of candles and fireplaces, combined with an increase in the use of combustible seasonal decorations, means more



risk for fire during the holidays..

### Top Ten Tips

1. Keep tree stand filled with water so the tree does not dry out quickly.
2. Avoid placing breakable tree ornaments or ones with small, detachable parts on lower branches where small children or pets can reach them.
3. Check lights for broken or cracked sockets, frayed or bare wires, and loose connections. Replace or repair any damaged light sets. Use no more than three light sets on any one extension cord.
4. Do not run cords under rugs, around furniture legs or across doorways.
5. Turn off all lights on trees and decorations when you go to bed or leave the house.
6. Unplug extension cords when not in use.
7. Never leave burning candles unattended or sleep in a room with a lit candle; make sure candles are on stable surfaces.
8. Keep candles out of reach of children
9. Don't burn candles near trees, curtains or any other flammable items
10. Don't burn trees, wreaths or wrapping paper in the fireplace

## Public Works Department

### Snow Plowing and Winter Safety

#### Please help us keep our roads clear

- At the road side, pile snow on the side of your driveway, on the downstream-flow of traffic. This reduces the amount of snow the plow truck puts in your driveway.
- Don't throw snow into the street; it creates a driving hazard and eliminates the plows from pushing the snow in front of your driveway.

#### Keep your mailbox safe

- Maintain a sturdy mail box; perform repairs every fall season.
- Add reflectors to mailboxes; Christmas lights work great too!
- Keep snow cleaned away from mailboxes; each winter event, accumulation becomes a block of ice and added plow pressure can cause damage.
- The most common contributing factor is the location, post too close to the road, or maybe it is located on a sharp curve and needs to be relocated.

If your mailbox seems to always be a target, contact us at [Public Works](#) and ask what can be done to prevent further strikes!

#### Winter snow shoveling and clearing tricks and tips

- Prevent back injuries by using small shovel loads and shoveling in layers, starting from the top.
- Shovel in time intervals, every hour or two, to reduce the amount of snow



accumulation.


