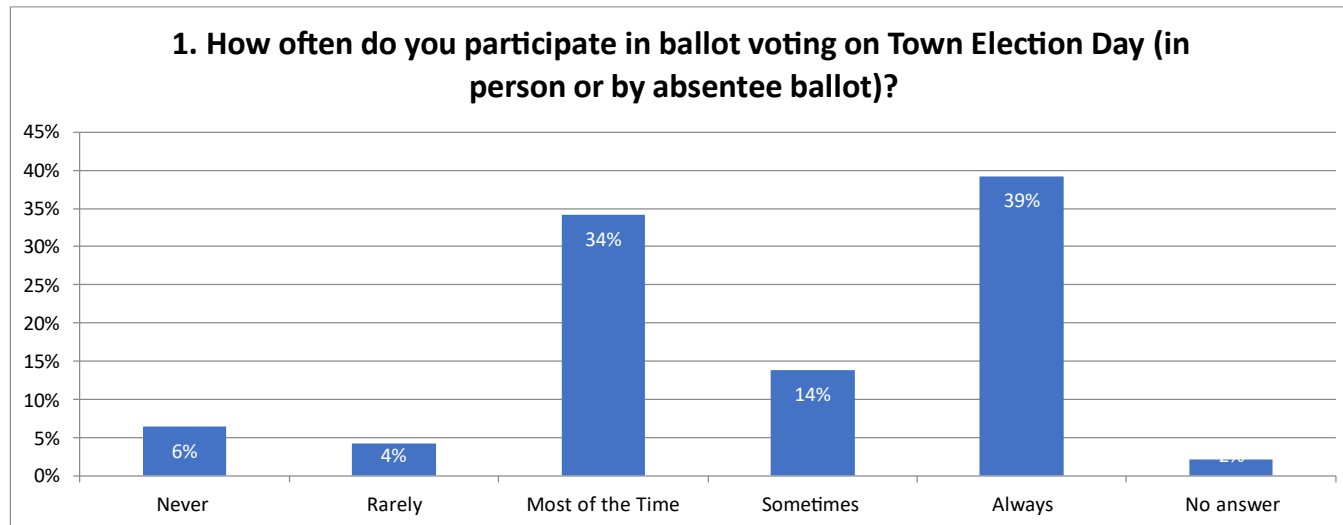

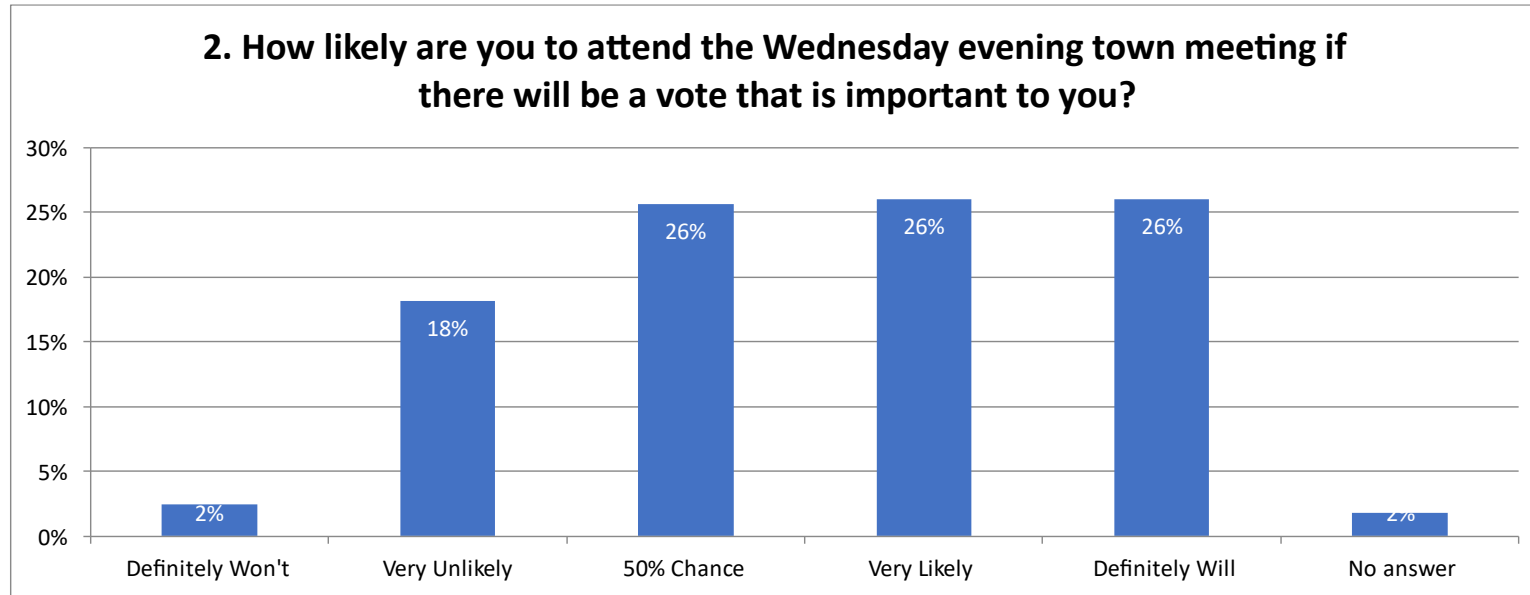
296 total records collected

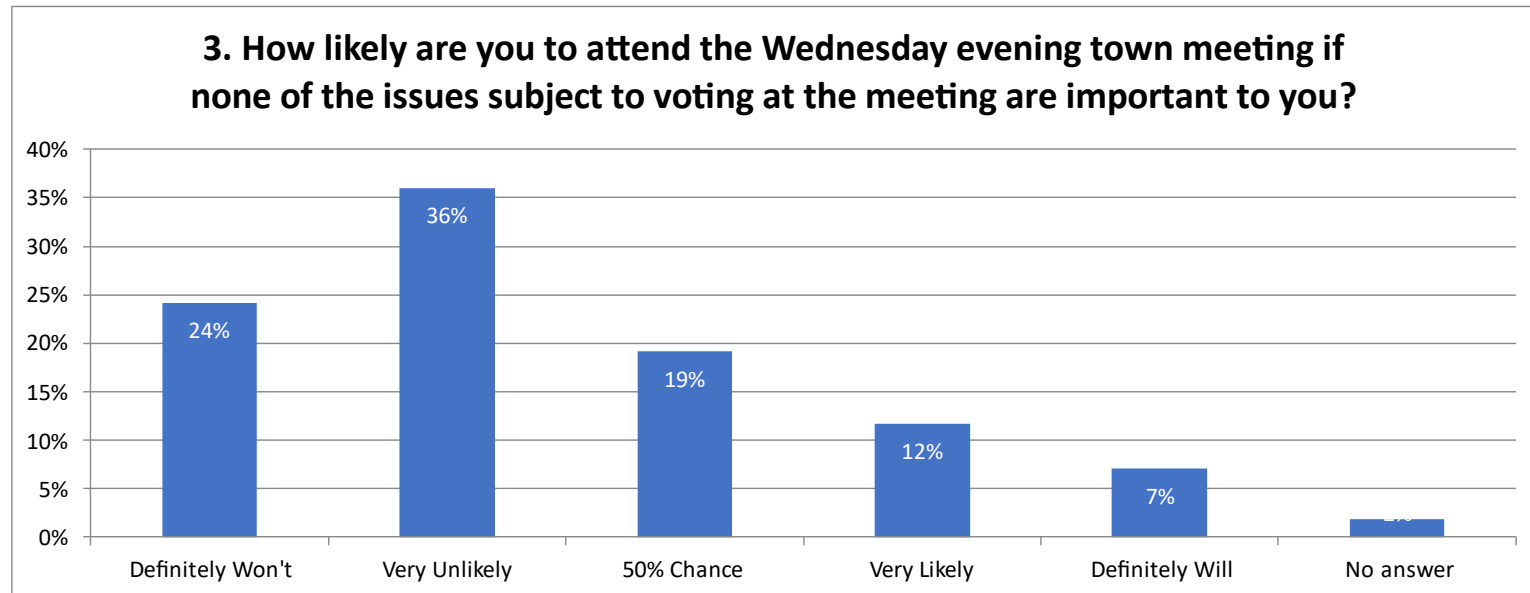
I.1 Total: 281 (includes 6 with no answer)

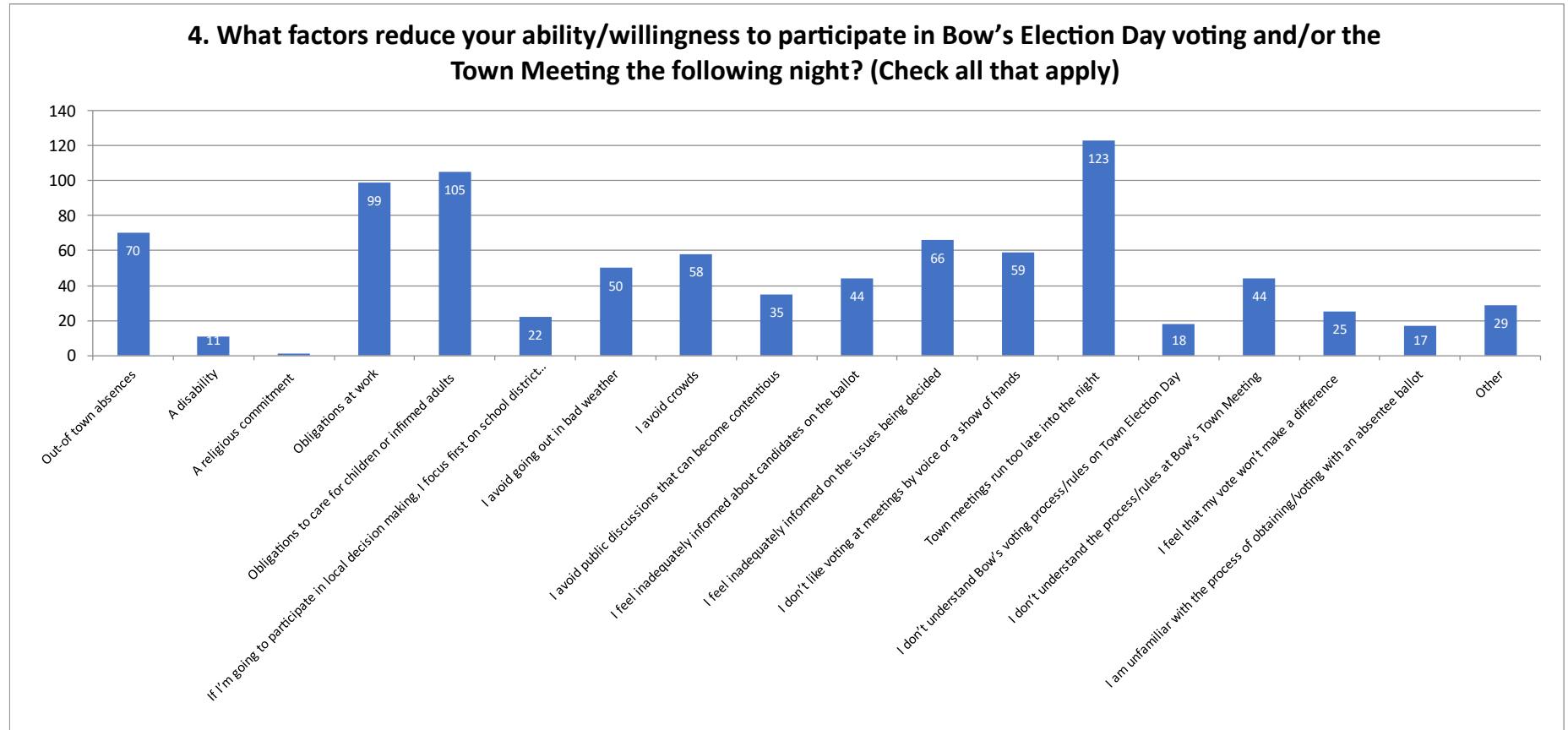


I.2 Total: 281 (includes 5 with no answer)



I.3 Total: 281 (includes no answer)





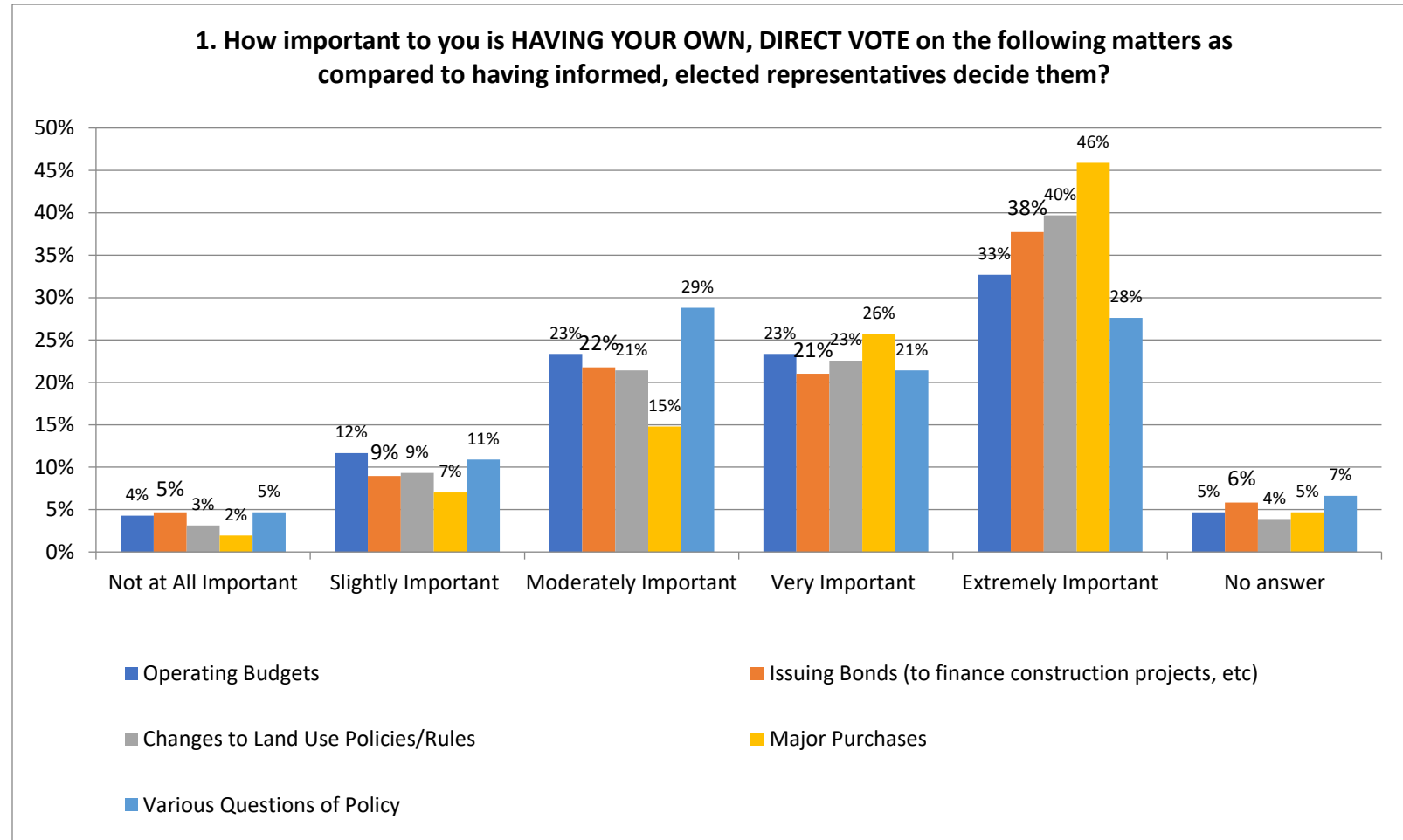
“OTHER” Factors that discourage participation in town meeting/election day (29 total):

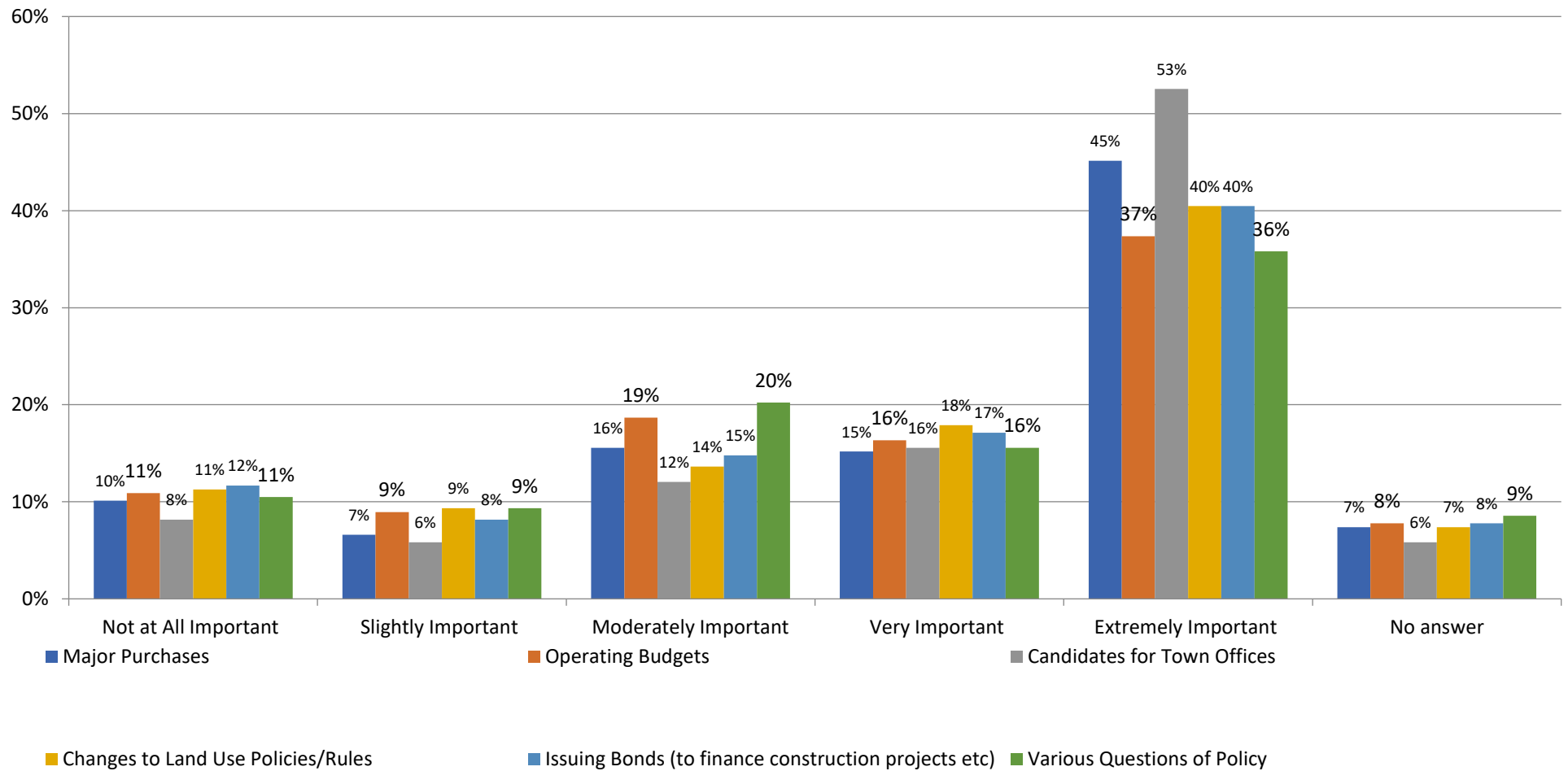
- Never concise; things drag on, postponed for nonsense, we need accurate and quick actions to get things done!

- The open discussions need to be limited for 3 minutes per person, for example. The majority of people already decided how they will vote.
- THE MEETINGS GO SO LONG-and while I do enjoy hearing others reasons for voting, there are far too many to listen to in a single evening!
- The people at the meetings are ridiculous
- The town doesn't adequately notify residents of what's going on at the town meeting. Meeting announcements are posted at various places in town but not areas that many residents frequent. I also the town website regarding meetings doesn't really state much of anything. The website should provide much more detail regarding the meetings than it does.
- Town meeting has become extremely cumbersome and frustrating. There are too many underinformed people clogging the works. Consider town council form of government.
- Town Meeting for a town of Bow's size is antiquated. Every voter/taxpayer deserves a vote.
- There's no absentee option for town meetings
- Ballot items are difficult to understand, and there is not way to get clarity in the voting booth

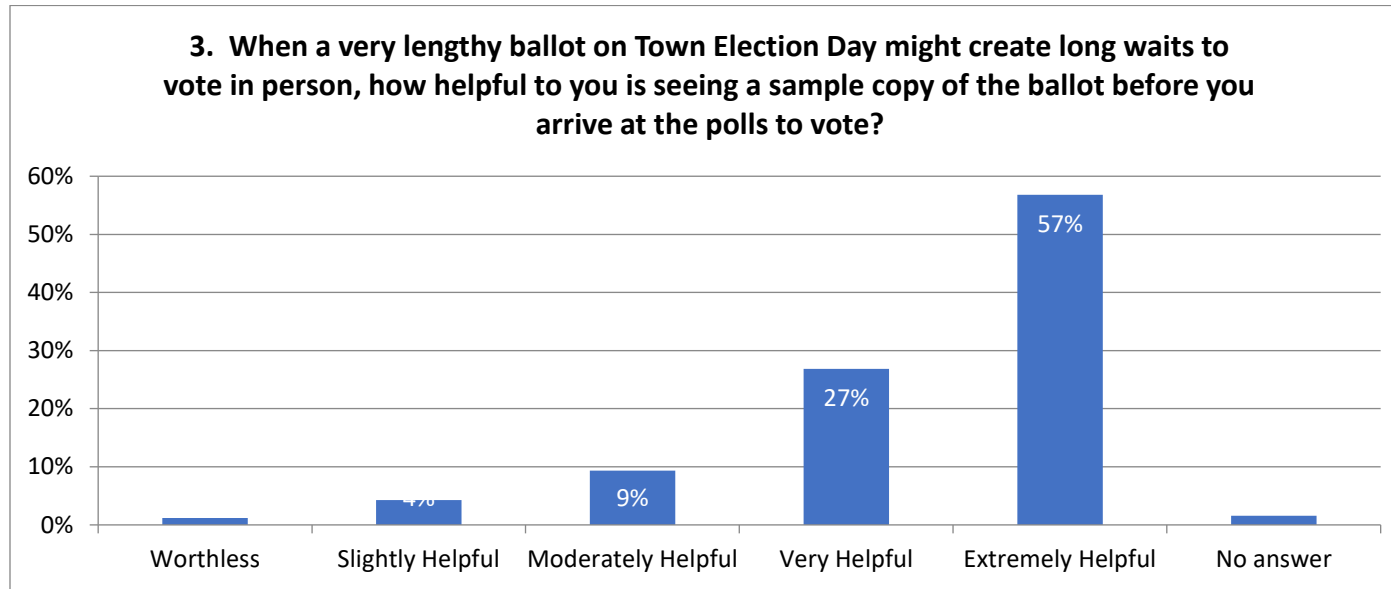

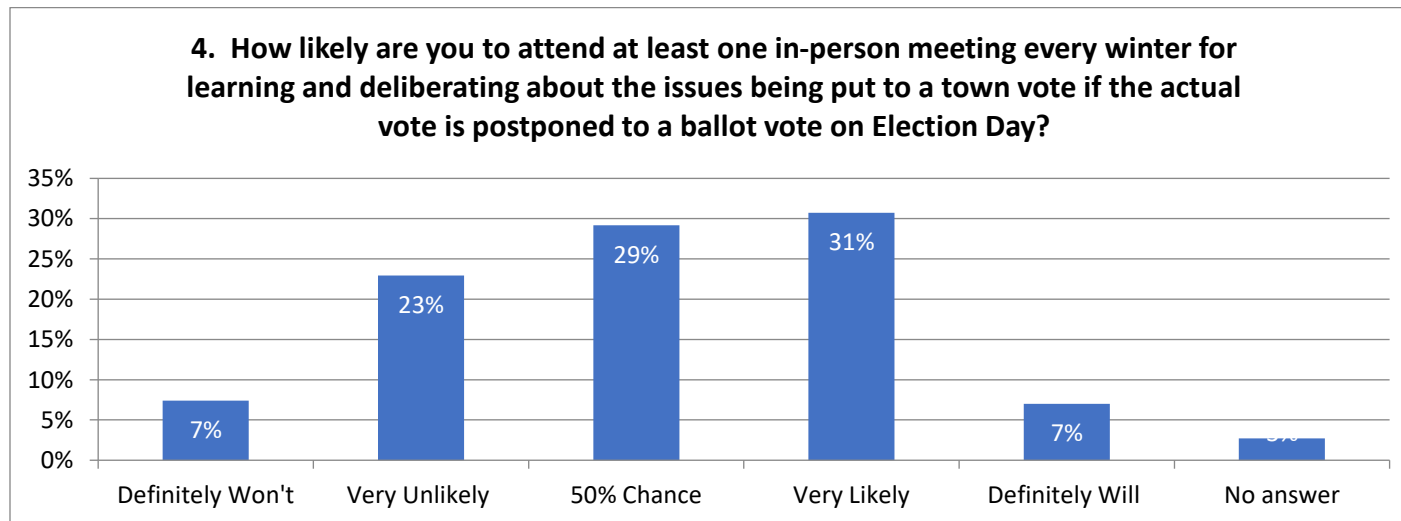
**2. When the following matters are put to a popular vote, how important to you is having the option of voting on them by ABSENTEE BALLOT?**

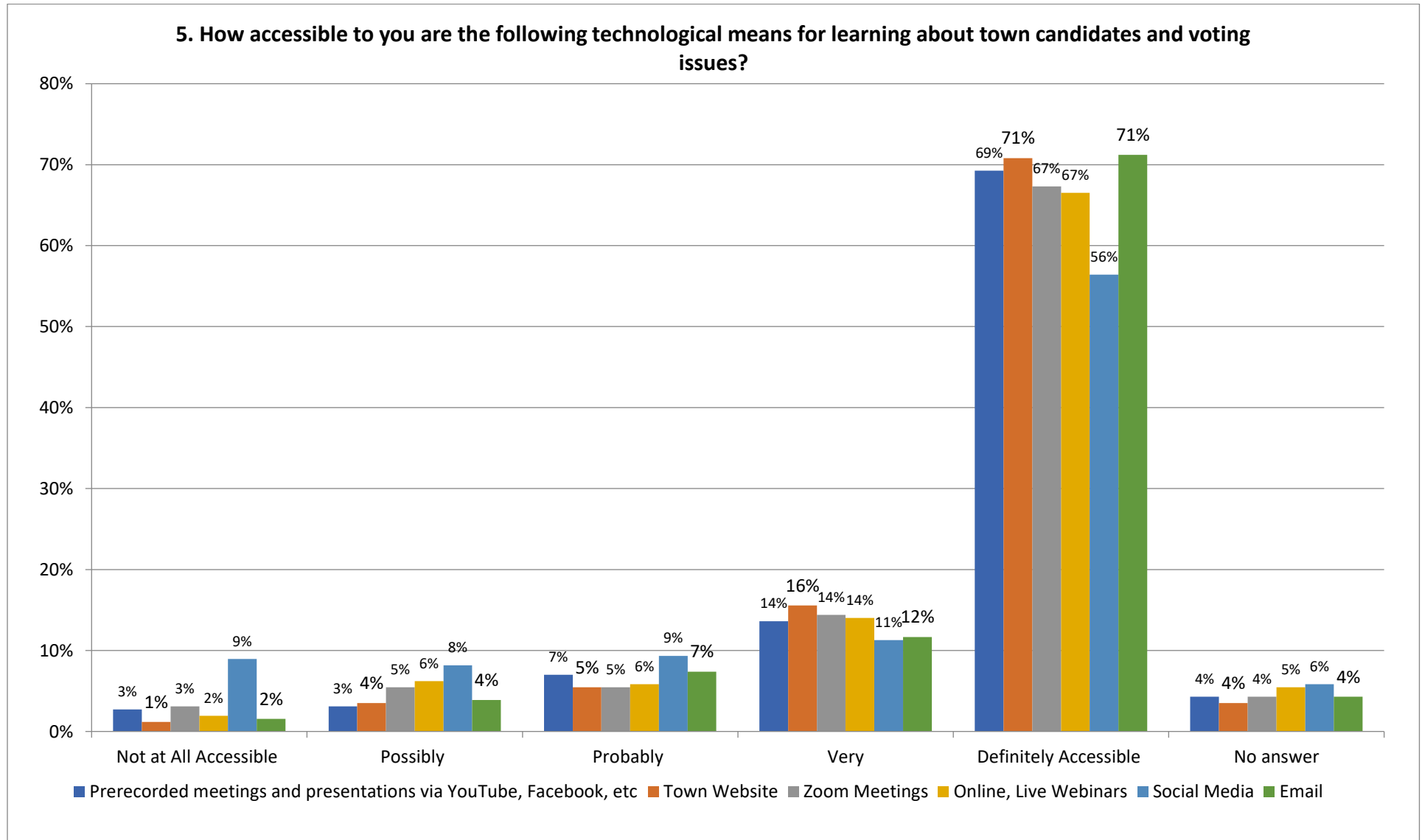

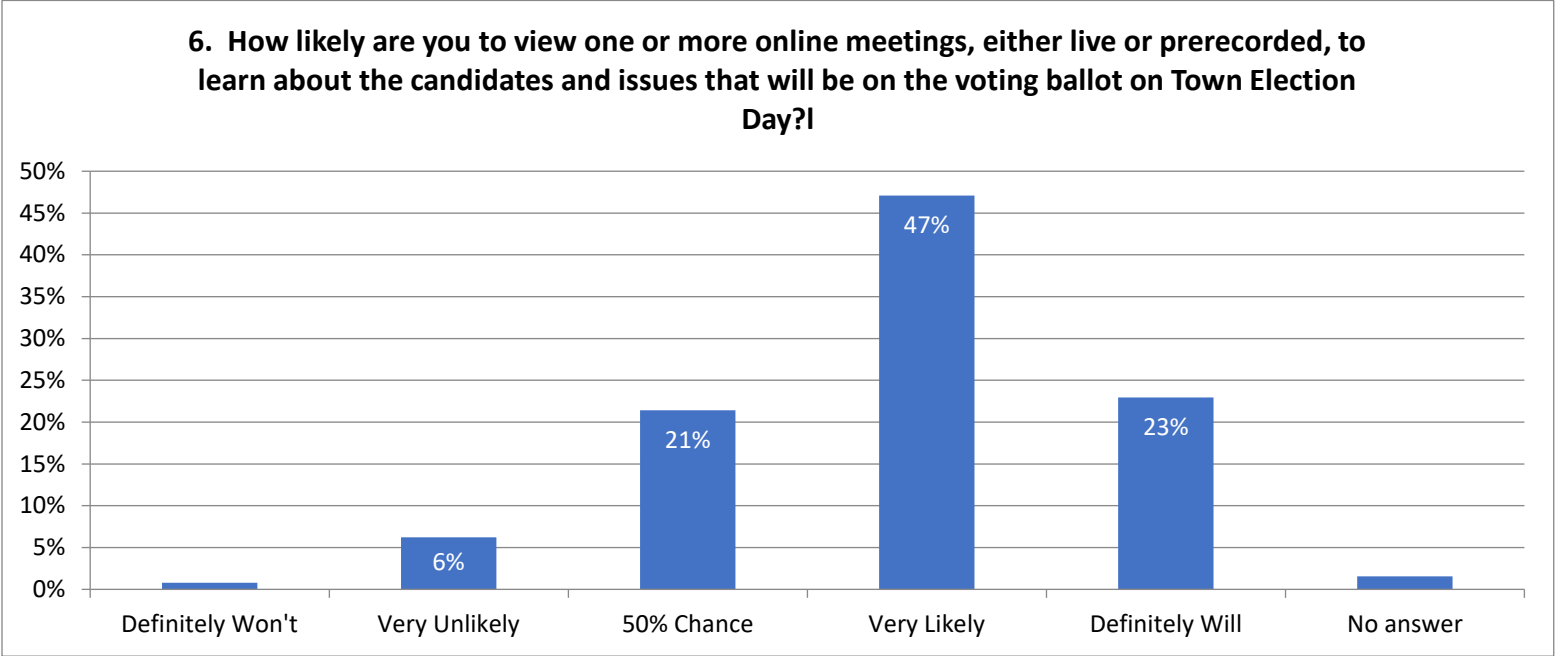

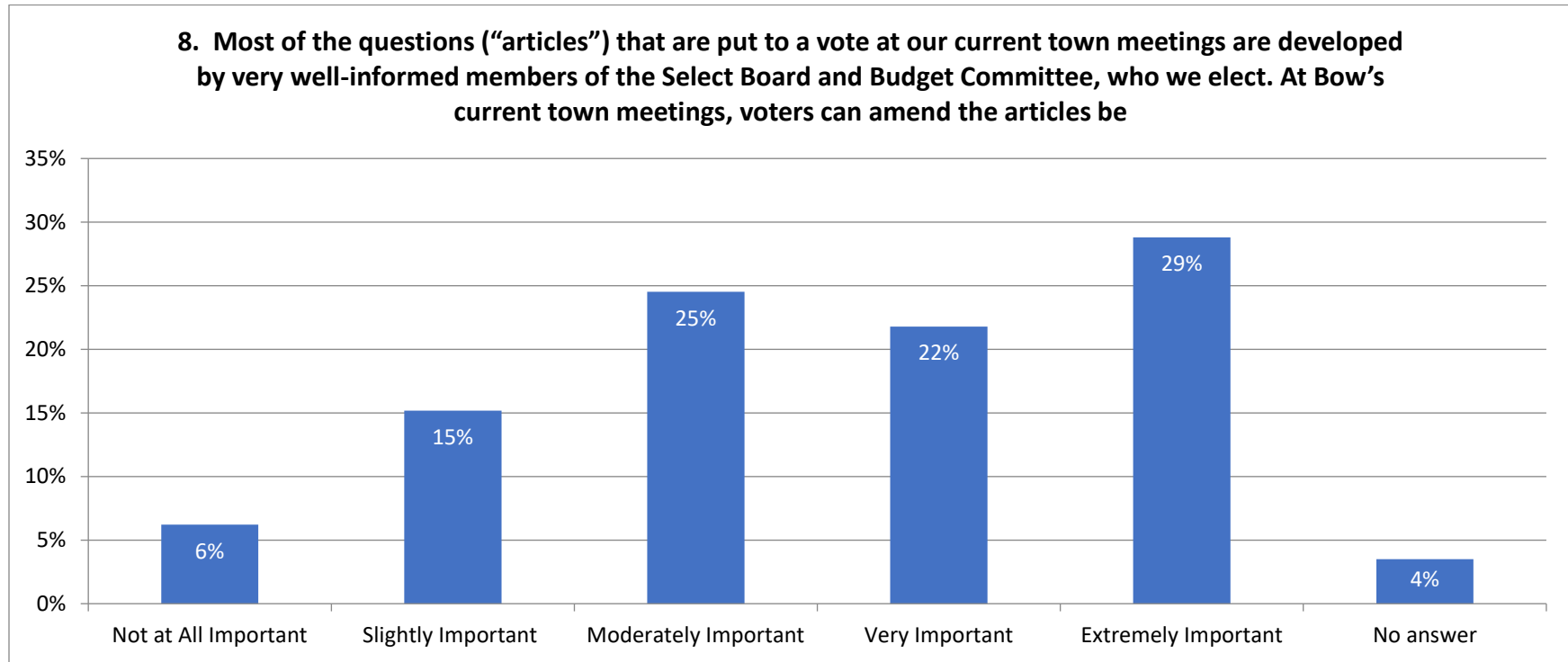

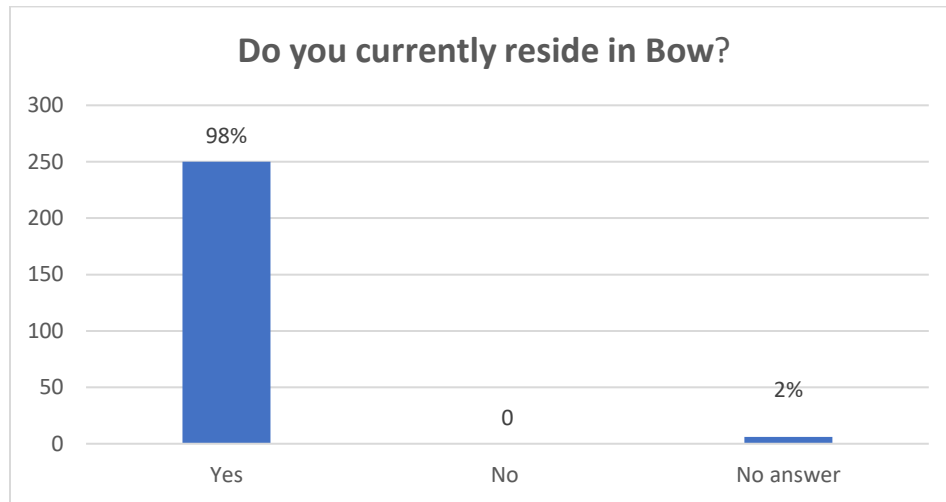
“OTHER” Factors that increase participation (13 Total):

- Ballot voting

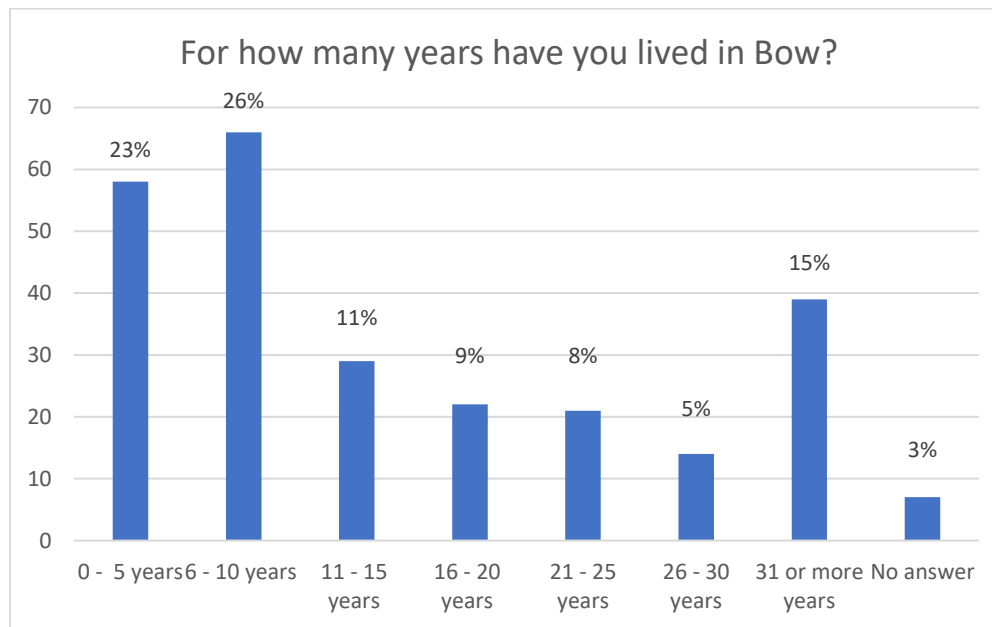

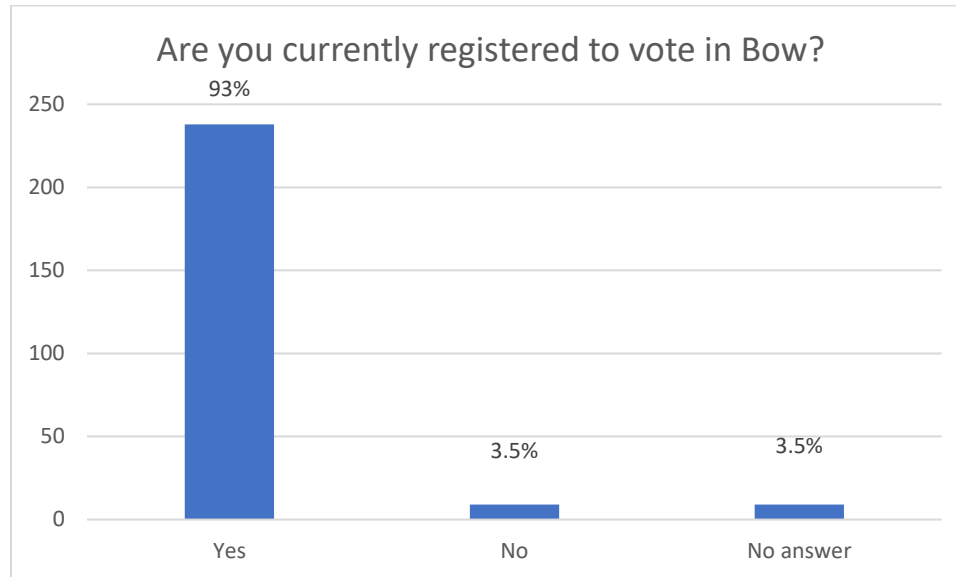

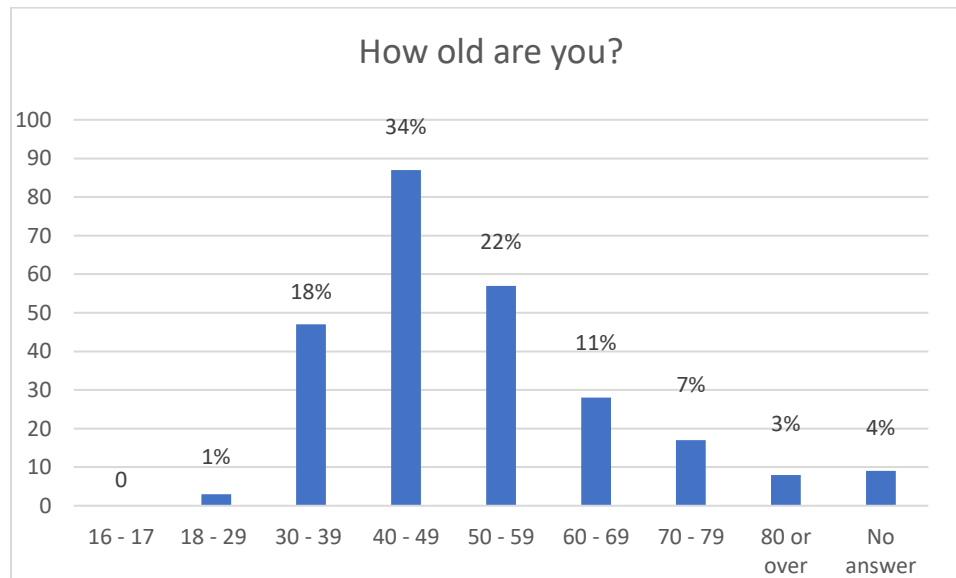
