More about NHSaves Home Performance with Energy Star Program (HPwES)

HPwES is a NHSaves whole house weatherization program. For qualified homes, professional energy auditors will conduct a home energy audit and present a quote to the customer outlining recommended cost-effective measures, their cost, and the rebate the utility will pay for each measure. A \$100 audit fee is due to the contractor at the time of the audit. The HPwES program covers up to \$6000 toward air sealing, insulation, lighting, and possibly ventilation measures (bath fans, etc.). Windows, doors, and heating systems are not covered in this program.

If the customer proceeds with renovations, rebates will cover the following: 100% of the energy audit, 100% of costs for air sealing, and 75% of costs for insulation, up to a maximum of \$6000. While funding is available, remaining out-of-pocket expenses may be financed at 2% through the Residential Energy Efficiency Loan Program; this loan program is only offered to HPwES participants. Also ask about 0% on-bill financing options. If the customer decides not to move forward with the recommended cost-effective measures, the \$100 is non-refundable and remains with the auditor.

How Do I Apply? The HPwES application is free and online. Click on “Test Your Home” at <https://nhsaves.com/learn/service/energy-audits-weatherization/>, and enter the following information:

- Heating fuel usage for the past 12 months. Do not include electric usage unless your home is heated with permanently installed electric baseboard heating.
- Conditioned square footage of your home. This is determined by the Living Area found on the town property tax card.
- Heating fuel source. Be sure to attach the receipts to the application, per the instructions.
- Utility provider
- Zip code
- Preferred energy audit contractor; select from the dropdown list or select “Utility Choice.”

Which Homes Qualify? The information entered in the application is used to calculate a Home Heating Index (HHI) value for the home. To qualify, Unitil and Liberty customers must receive an HHI of 8. This is less restrictive than a year ago, making this a great time to apply.

My Home Qualifies – What Next? Your qualifying application will be sent via email to the utility, and the program administrator(s) will verify your qualification. Please make sure to attach oil, propane, kerosene, or wood pellet receipts to the application; otherwise, there will be a delay in processing. Once verification is complete, you will be contacted to confirm your participation into the program and notified if there is a waiting list or if you have been assigned to a contractor. If assigned to a contractor, you will be contacted by them to make an energy audit appointment.

IMPORTANT: Funding is limited for this program and wait times can be long.

My Home Does Not Qualify – What Now? You will be given the option for a Visual Audit. Rather than an energy audit, this is an opportunity to receive energy-saving products at no cost to you. To be eligible, the property must have at least one traditional thermostat that can be upgraded to a Wi-Fi thermostat. Products that may be offered, with free installation, are: Wi-Fi thermostat; LEDs for fixtures used for more than three hours/day; low-flow showerheads; aerators; pipe-wrap insulation (up to 6’); and domestic hot water turndown.

You may also wish to pursue an energy audit and insulation and/or air insulating measures independently. Although you will not have access to HPwES rebates, you can still benefit from long-term reductions in heating and cooling bills through greater energy efficiency.

IMPORTANT: The HHI determines HPwES eligibility, but not qualifying does not mean your home is energy efficient. Also, program requirements can change, so you may wish to try again later if you do not qualify now.
